#### **Resolved** – Objection

- (i) Members object to the extended opening hours to 8pm due to the close proximity to residential dwellings with the effect of noise and light pollution.
- (ii) Members request that car parking is restricted to the garage forecourt and not the roadside verges.
- (iii) Members expressed a concern that the application was retrospective in nature.
